2. Quality Control Division under PWD will be at the disposal of the Committee as and when required.
3. The Committee shall be supported/assisted in its mandate by the Programme Implementation, Monitoring & Evaluation (PIME) Unit under the State Institute for Transformation, Planning & Programme Implementation Department.
4. The Committee shall take steps to ensure timely Completion of Projects.
5. The Committee may, if absolutely necessary, recommend revision of estimates of works / projects based on the site inspection report.
6. The Committee shall take up other functions as may be assigned to it from time to time and submit recommendations to the Government.
