**Terms of Reference**

1. The Policy Coordination Committee will consist a team of experts in policy matters and government programmes. The Committee members will be entitled to TA/DA at the rate admissible to Addl. Secretary to the Government of Mizoram while performing duties assigned by the Committee ,and Co-opted members will be entitled TA/DA at the rate admissible to Under Secretary, Govt. of Mizoram while performing duties assigned by the Committee.
2. The Committee members shall be entitled to sitting allowance at the rate of Rupees One Thousand per sitting or as may be decided by the Government from time to time.
3. The Committee will play a coordinating role with various departments to implement government policies and programmes to achieve the core policy of convergence of the present government.
4. The Committee will act as an advisory body to various departments and do networking with supporting agencies like financial institutions, service providers, technology providers, etc.
5. The committee will help look after various central schemes and project spread across different departments and centralize them in association

with the Planning & Programme Implementation Department/ Mizoram State Planning Board.

6. The Committee will identify, screen, and examine the feasibility of various handholding project proposals to avoid any duplication.
7. The Committee may also help the Department of Agriculture in the implementation of Mizoram State Agriculture Procedure Marketing (Development and Regulation) Act, 2008 as and when necessary.
8. The Committee may invite /consult representatives from various department's institution, cooperative societies, financial institution, PSUs, NGOs, and experts, etc as and when the need arises.
9. The Committee shall appoint new members if need arises.
