Terms of Reference:

- a. It shall function as an advisory body to the Government of Mizoram on all matters relating to economic and social development of the State of Mizoram.
- b. It shall provide direction, guidance and support to state departments for the accomplishment of Sustainable Development and Reform Policy and submit recommendations to the Government as required.
- c. It shall determine plan priorities and advise the Government on the formulation of development plans for the most effective and balanced utilization of State's resources.
- d. It shall guide the Government in linking policy with budgeting so that policy direction dictates planned budgetary allocation to achieve developmental objectives.
- e. It shall take up such other functions as may be ascribed to it from time to time.

Terms of Engagement:

- Members of the Mizoram State Planning Board shall be entitled to sitting allowance at the rate of Rupees two thousand per sitting.
- b. They shall also be entitled to TA/DA at the rate admissible to the Secretary to the Govt. of Mizoram while performing duties assigned by the Board as decided by the Government from time to time.

The Mizoram State Planning Board shall be provided with secretarial service and support by Planning & Programme Implementation Department (Research & Development Branch), Government of Mizoram.
