anctions of the DPC: In the light of the Provision of Article 243ZD of the constitution of Ila, District Planning Committee shall be constituted in every district to plan, monitor, evaluate, review and coordinates development initiatives in the district and to exercise such other powers as may be assigned by the Government from time to time. The Committee shall, in preparing development plan, have regard to : (a) Matters of mutual common importance in the society; (b) Spatial particularity; (c) Sharing financial, physical and natural resources; (d) Integrated development of infrastructure and environmental conservation. The District Planning Committee shall perform the following functions:

- Identification of local needs and objectives within the perspective of national and state goal;
- Collection, compilation and updating of statistics of the natural and human resources ii. of the district:
- Mapping of the infrastructure facilities, identification of growth drivers, manpower planning and skills gap assessment at village, block and district levels;
- Preparing blueprints of development plans for the district by identifying critical development gaps in the district through the use of various indicators such as those based on SDGs - and identifying national and State programmes to address the stated gaps; ·
- v. Persuasion, evaluation and review of plans of the central domain, centre sponsored plan, plan of the State domain, and the local area development schemes including GDPD on the legislators, account, in the district;
- vi. Submission of progress reports of the development works within the district to the State Government;
- Ensuring, cooperation of non government organizations in the process of all round vii. development of the district;
- Advising the State Government regarding the important initiatives of the State viii. domain in the process of the overall development of the district;
- Other functions assigned by the State Government, if any. ix.
