Terms of Reference:

- a) It shall function as an advisory body to the Government of Mizoram on all matters relating to economic and social development of the State of Mizoram.
- b) It shall make an assessment of the State resources, determine development priorities and advise the Government on the formulation of development plans for the most effective and balanced utilization of State's resources.
- c) It shall guide the Government in linking policy with planning and budgeting so that policy direction dictates planned budgetary allocation to achieve developmental objectives.
- d) It shall coordinate, review and monitor the State Flagship Policies & Programmes.
- e) It shall monitor and evaluate Central and State schemes, programmes and projects, EAP and other loan projects etc., and make recommendations to the Government in order to facilitate convergence of developmental activities, prioritization of financial resources for developmental purposes, and effective implementation of developmental works.
- f) It shall coordinate sectoral surveillance to identify factors which hinder socio-economic development and suggest corrective policy measures and precision interventions to address such issues.
- g) It shall take up such other functions as may be assigned to it from time to time and make suitable recommendations to the Government.

- h) The Non-Official Board members shall be entitled to sitting allowances at the rate of Rupees One Thousand per sitting subject to a maximum of Rupees Three Thousand per month or as may be decided by the Government from time to time.
- i) The Non-Official Board members shall be entitled to TA/ DA at the rates admissible to Joint Secretary to the Government of Mizoram while performing duties assigned by the Board.

The Mizoram State Planning Board shall be provided with secretariat assistance and support by Planning & Programme Implementation Department, Government of Mizoram.
